This is the last letter you will receive before the Reunion so make notes and plans now to attend. Start hoping it won't rain, gather pictures, documents, family data, etc. to bring with you. About 150 people came last time (in the rain!). We do hope there'll be 300 this time.

Our genealogist, Mr. Clark, is still working hard for us, and he has found several things of interest. Some of it is what we might call 'negative' data - in other words something we thought might be true but has proven not to be so. This doesn't add much to our material, but actually is just as important to our end result as a positive fact and the genealogy has to be built on accurate information. Inaccuracies make very poor basis for family trees, or anything else.

The first positive fact found is that the Peter Schlosser who lived in Lebanon Twp. Lancaster County, Penn. is the same Peter Slusser who lived in Washington Co. Maryland and died there in 1790. This is proven by an Indenture of Mortgage made 29 May 1767 between Conrad Mentzinger of Lebanon Twp., Lancaster County, Pa., yeoman, and Peter Slousser of said place, yeoman, for 1149/114/0, due 19 May 1768 1/714/17/0. This land adjoined land of Jacob Berenson, Joseph Serick, Adam Waggoner, Pater Harlan and Peter Benelick, containing 5.

100 acres more or less. Signed 29 May 1767, Rec. 10 July 1767. Source: Lancaster County Pa. Court Deed Books.

And then, in 1792, "Account of George Slusser, administrator of Petter Slusser of Washington County, Maryland, deceased ... "This accountant chargeth himself with amount of money received of Conrad Mentzinger for a mortage of 1/15/0/0... and this accountant claims an allowance for money paid Registrar paid filed 1/1/7/0. Balance due estate £13/2/0. George Slusser, adm. of Peter Slusser, dec'd acknowledged having received full satisfaction for this mortgage from Conrad Mentzinger, signed 14 August 1792. (Wash. Co. Md. Accounts, Liber 1, f. 337.)

So this proves that Peter Schlosser did in fact move his family from Lebanon Twp. Lancaster County, Pa. to Washington Co. Md., probably around 1780, when the Schlossers disappear from the Lebanon Co. church records.

A George Slusser was also administrator of the estate of a Peter Slusser, in Washington County in 1805. Record reads as follows:

Deed of John Slusher from George Slusser 19 Nov. 1805, Recorded 21 Jan. 1806.

At the request of John Slusser, a deed of release was recorded whereas Peter Slusher late of Washington County, Md., died intestate, his heirs:

- 1. John Slusser
- 2. George Slusher, of Virginia
- 3. Leonard Middlecaulf and Elizabeth his wife.

all of Washington County, Md. release all rights and title to  $249^{\pm}_{2}$  acres of land called "Slosser's Chance" for 1000 pounds oaud by John Slusser. George Slusher's wife, Polly, renounced her dower rights.

Elizabeth Middlecaulf and Catherine Koffman were the Slushers, apparently daughters of Peter Slusher.

Now, this last Peter was probably the Junior Slusher, since this transaction took place in 1805, 15 years after 1790 when Peter, Sr. died. Also, there is a

tombstone in Rose Hill Cemetery in Hagerstown, Md. which says: Elizabeth Schlosser, dau. of P. Schlosser and wife of Leonard M. Middleksuff, b: Mar. 28, 1770 d: Mar. 10, 1833. Since we have always assumed Christopher was Peter Sr.'s youngest child and Elizabeth was born 13 years after Chris this adds weight to this assumption.

There is also on record a listing of heirs of Herman Painter's land and that of Peter Ringer 15 Jan. 1822, as follows: Elizabeth Painter, widow; George Slosser and wife Mary; John Slosser and wife Elizabeth; Jacob Coffman and wife Anna; Henry Huffman and wife Catherine.

One version of a family tree we have seen states that Peter Slusher, Jr.'s son John married a Painter (Panter in some spelling) and her sister married George Slusher, a son of Peter Jr's brother Henry.

But since we don't even know whether Peter Sr. had sons Peter and Henry yet, we certainly aren't going into that relationship at present! We have enough trouble as it is.

Now: about the parents of Peter Schlosser (1710-1790) whom we have mentioned from time to time and whom we thought might be a brother to George Ernst Schlosser (b: 1714) of Philadelphia, who was born in St. Arnaud, etc. same place Peter was said to have been born on the DAR application form we have quoted so often and now wish we'd never laid eyes on, since the information of the application definit-ly has two Peter Schlossers thoroughly mixed up (See Vol. I, No. 2, pg. 1, Jan. Jacob Koffman and Catherine his wife 1970): I shall quote verbatim from what the genealogist has found about this which is as follows:

> "It has been stated by some researchers that Peter Schlosser (1710-1790) was the son of Rev. Johann Georg Schlosser, a German Lutheran minister, and his wife Sophia Johanetta Margaretta. The reference in support of this was Egle's Notes and Queries, Third Series, Vol. 3, pp 188-9, a biography of George Ernst Schlosser of Philadelphia. There is no mention in Egle's article of a Peter, but apparently the assumption was made that George Ernst and Peter were brothers. (Cont'd)

"I have attempted to verify this assumption. Since St. Arnaud, Nassau-Saarbruck, and Dietlingen (the German place-names in Egle) do not appear on modern maps or in modern Gazetteers, it was first necessary to determine the German residences of Rev. Schlosser. A letter from Dr. Kelin, Leiter des Stadtarchivs, Saarbrucken, translates in Part:

"The St. Arnaud concerning which you inquired is most probably the part of Saarbrucken known today as St. Arnaul. village of St. Arnaul rose in the middle ages as one of the churches founded in the 6th-7th century which bore the names of the Bishop of Metz, St. Arnaul. The seminary of St. Arnaul was considered in the middle ages as the second seat of the bishe not requested a search of their church pric of Metz and was indeed the archbishop's church. In 1569, with the inception of the Reformation, the dependency was secularized by the Count of Nassau-Saarbrucken, but continued to remain the re-

"The neighborhood of St. Arnaul, which lies just west of old Saarbrucken, was incorporated into the city of old Saarbrucken in 1896. The neighboring cities to old Saarbrucken, St. John and Malstatt-Burbach. were united in 1909 into the metropolis of Saarbrucken.

"... relatives of the family Schlosser are traceable from the beginning of the 17th century in old Saarbrucken and St. John and their environs."

"In response to my second letter inquiring about a Peter Schlosser born 20 January August 1722. 1710 (buried in the Old Reformed Graveyard Sharpsburg, Md.) Dr. Kelin wrote:

"... I can report to you that the Peter certained either in the church books of St. Arnaul or in the church books of Saarbrucken and St. John.

"The baptismal record of George Ernst Schlosser, born 7 November 1714 at St. Arnaul, and son of Johann Georg Schlosser. evangelical pastor of St. Arnaul and his wife Sophia Johanette Margaretha, can be found in the church book of St. Arnaul (Book 17, pg. 24, number 7. Two other children were also born to this couple in St. Arnaul: Maria Gertrude, born 26 April

1711, and Wilhelm Christian, born 20 September 1713 (Book 17, page 21, number 1 and page 23, number 6.)

"Johann Georg Schlosser was pastor in St. Arnaul from 1710 to 1715. He lost his pastorate in 1715 because of adultery. (A Ruppersperg, St. Arnaul -- History of the Religious Organizations and the City, 1930 p 19). Since he obviously could not remain a resident of St. Arnaul or Saarbrucken, additional offspring of his could have been born elsewhere."

"According to Egle's article Rev. Schlosser moved to Strassburg when Georg Ernst was six months old (i.e. May 1715). Perhaps other daughters were born there; I have books or civil records. Egle's "Diettingen" is, in fact, Dietlingen:

"Pastor Johann Georg Schlosser came to Dietlingen in July or August 1722. Just before that he was for two years and nine ligious center of the state of Saarbrucken. months the pastor at Huchenfeld near Pforzheim, a few kilometers distant from here. Pastor Schlosser died here in Dietlingen on 6 March 1746 and was buried on 8 March 1746. What then happened to his family cannot be learned from my books. Neither has the Mayor's office of Dietlingen any information concerning them.

> "I have only one entry concerning his children which, however, may be useful to you: Johann Philipp, dearly beloved third little son of Johann Georg Schlosser and his wife Sophia Johannetta Margaretha, died between 8 and 9 in the evening of 16

. "This would exclude the possibility that Pastor Schlosser had had a third son Peter born before 1722 in addition to wilhelm Schlosser sought by you... could not be as- Christian and Georg Ernst, both born before 1722. The Johann Philipp mentioned died, according to this entry, at the age of 2 years less 11 weeks and 2 days and so must have been born on 29 October 1720.

> "I was recently in Huchenfeld and could find there nothing more than confirmation for the son Johann Philipp; he was born on 30 October 1720."

Mr. Clark says that "on the basis of these communications, I believe it is possible to state absolutely that Johann Georg Schlosser did not have a son Peter. No

record of the birth of a Peter exists in St. Arnaul; if Rev. Schlosser had had another son after his departure from St. Arnaul and before his arrival in Huchenfelt, then Johann Philipp would not have been his third son. There is no record of the birth of a Peter in the Huchenfeld church book. Since Rev. Schlosser lived and was the pastor in Dietlingen from 1722 until his death in 1746, his children would surely have been baptized in his church there. The church records for that period do exist today and they contain no entries of the birth of additional Schlosser children. Having said all this, perhaps I should make one qualification: Johann Georg Schlosser did not have a legitimate son Peter." (End of quote)

Now isn't that perfectly splendid? To know someone who knows how to go about finding that type of thing, and writing - people in Germany - and knowing where to write in the first place, and how to read the answer when you get it?

And I suspect its just as well we did not turn out to be descended from the Reverend Johann George, if we could help it.

Mr. Clark is presently working on trying to straighten out the relationship between the two Peter Slussers in Washington M. F. Slusher, Mar. 15, 1856 - June County and awaiting another letter from n Germany about Peter's possible place of birth, among other things. We'll tell you all about that at the reunion if it doesn't John B. Hylton, Jr. Apr. 1, 1846 come before this letter is stencilled and mailed. You'll remember that one of the Poters in washington Co, had a wife Mary and one had a wife Susannah. They lived at the same time and we have thought they were father and son.

Continuing our project of listing the kinfolks buried in the cemeteries in Floyd County, the following is from the Jacob Slusher cemetery, located 4 miles west of Floyd Court House on the farm of George L. Slusher:

Here is a rather interesting article from a magazine called "Farm-the receipt whereof he doth hereby land" published twice a month by Farmland Industries, Inc. 3315 N. Oak Trafficway, Kansas City, Mo. It was sent to us by Mrs. Ben Slusher. Lexington, Mo. It is entitled:

"Jottings from a European Journey"

"One of the farms we visited in this area east of the Rhine was at Winterschied, not far from the Auto-all that part of a tract of land bahn between Cologne and Frankfurt. It provided a good illustration of what is taking place in German agri = at the Beginning tree of a tract of culture. The active farmer is Martin Schlosser, 32 years old, who has ning thence east twenty-eight per 68 acres, mostly in pasture. He milks 31 cows and is quite disap-

pointed that he is unable to find additional land for expansion. Schlosser farm is one of four in a community where there were twelve in 1960. Schlosser sells his raw milk through a cooperative.

If neighboring land were available, Schlosser said, he would have to pay about \$1200 an acre if he bought it, and about \$50 if he rented. This would be high priced pasture in the United States. Schlosser is considered to be on the borderline, - between expanding and cutting unit costs or quitting and finding a job in industry." (August 1971)

one hundred perch north seventy three degrees west thirty perches north forty eight degrees west fourteen perches north eighty two degrees west twenty two perches south thirty three degrees and thir-And" minutes east thirty six perches east seven perches then with a straight line to the beginning Containing four acres and a half of an acre of Land more or less Together with all and Singular the premises and appurtenances belonging or in any manner of ways appertaining TO HAVE AND TO HOLD the said parcel of Land with all and singular the premises herein mentioned and intended to be hereby granted with the appurtenances thereto belonging unto the said Peter Slusser his heirs and assigns forever to the only use and behoof of him the said Peter Slosser his heirs and assigns forever and the said Conrad Ringer for himself and his heirs the said part of parcel of land all and singular the premises with the appurtenances unto without being compelled thereto by him the said Peter Slosser his heirsany threat of her said husband or and assigns and against any other person or persons whatsoever claiming or to claim from by or under him the said Conrad Ringer and his heirs shall and will warrant and forever defend by these presents and the said Conrad Ringer and his heirs shall and will from time to at the proper cost and charge in the law of him the said Peter Slosser his heirs or assigns make do or execute or cause to be made done or executed all and every such further and other act or acts devise or devises assurance or assurances whatsoever requisite in the premises for the better and more suremaking of the bargained premises unto him the said Peter Slo= sser his heirs and assigns forever by it by of these presents or by any other Lawfull means as by Floyd, Va. At the foot of the same deed was the following wrote - to wit Washington County Sct. On the first Day of Decr 1786 came before us the subscribers two Justices of the peace for the County aforesaid W. Conrad Ringer and acknowledged the above Instrument of writing to be his act & deed and the land and pre mises above mentioned to be the right and estate of the above named Peter Slosser his heirs and assigns forever at the same time came Eliza beth wife to the said Conrad Ringer and acknowledged her right of Dower to the above mentioned land and pre mises and said that she did the same with her own free good will fear of gaining his displeasure acknowledged before

It was signed by the same two witnesses and then Corad Ringer said he has received the eighty pounds for the land.
